# The 2nd Meeting of the 14th ASOSAI Research Project



26 June 2025

The 2nd Meeting of the 14th ASOSAI Research Project, under the theme "Leveraging Artificial Intelligence to Enhance Efficiency and Effectiveness in Public Auditing," took place online on 26 June 2025. The meeting was hosted by SAI Thailand, in its capacity as the Project Leader, and attended by representatives from 17 ASOSAI RP Members.

The meeting commenced with opening remarks by the Project Leader, Dr. Sutthi Suntharanurak, State Audit Advisor, SAI Thailand, followed by the official proceedings, which were divided into four sessions as follows:

His presentation highlighted key approaches, strategies, and experiences related to integrating AI into the audit process. 
#### Session 2: Presentation on Draft Chapter 2 -**Literature Review**
